

CANCELLATION/ NO SHOW POLICY:

Late Arrival Policy: If you are late for an appointment, you will be seen as soon as we can possibly accommodate you, and for the length of time remaining to your appointment. If you are over 20 minutes late to your appointment, you may have to be rescheduled and you will be charged a \$25 fee. Initial_____

Cancellation Policy: If you need to cancel an appointment, please call us ASAP (24 hours notice) so we have the opportunity to offer your appointment to another patient. If less than 24 hours notice is given, you will be charged a \$25 cancellation fee. Initial_____

No Show Policy: If you do not show up for a scheduled appointment, you will be charged a \$50 no show fee. Initial_____

Repeated late cancellations or no-shows are disruptive to the optimal delivery of care to you and our other patients. NECK DISABILITY INDEX

Please answer every section and mark in each section only the ONE box which applies to you at this time. We realize you may consider two of the statements in any section may relate to you, but please mark the box which most closely describes your problem TODAY.

1. PAIN INTENSITY
